All maps are in this packet. Color guards should report one hour prior to performance time. The Show Host will provide sound equipment with auxiliary cords for MP3 or iPod use in both Warm-Up areas.

Unit Badges

- Each unit registered in TCGC will receive two (2) Unit Badges.
 - Additional Unit Badges are \$50 each.
- Unit Badges will be issued to members listed on the TCGC Unit Badge Application only (found in CompetitionSuite under Resources).
- Up to 2 staff members can be listed per application.
- Any additional Unit Badges your unit purchases must be accompanied by additional applications.
- Unit Badges will be personalized with the approved staff members name. Only that individual is authorized to use that badge.
 - Unit staff members found in violation of this policy will have their badges revoked for the remainder of the season and disciplinary action will be taken against the unit according to the TCGC Code of Conduct.
- Units will receive 8 backside wristbands

Front Side Bleacher Rows: 12

Seating Capacity: 956 Approximate

- There are no permanent obstructions above the competition floor.
- Units do not enter the competition area directly from the outdoors.
- There is electrical power available at the front and back sideline.
- Units do not exit the competition area directly to the outdoors.
- The hallways will be utilized for prop storage prior to the competition.
- There will be a black vinyl tarp measuring appx 60' x 90' covering the wooden gym surface.
- An indoor space is available for floor folding.

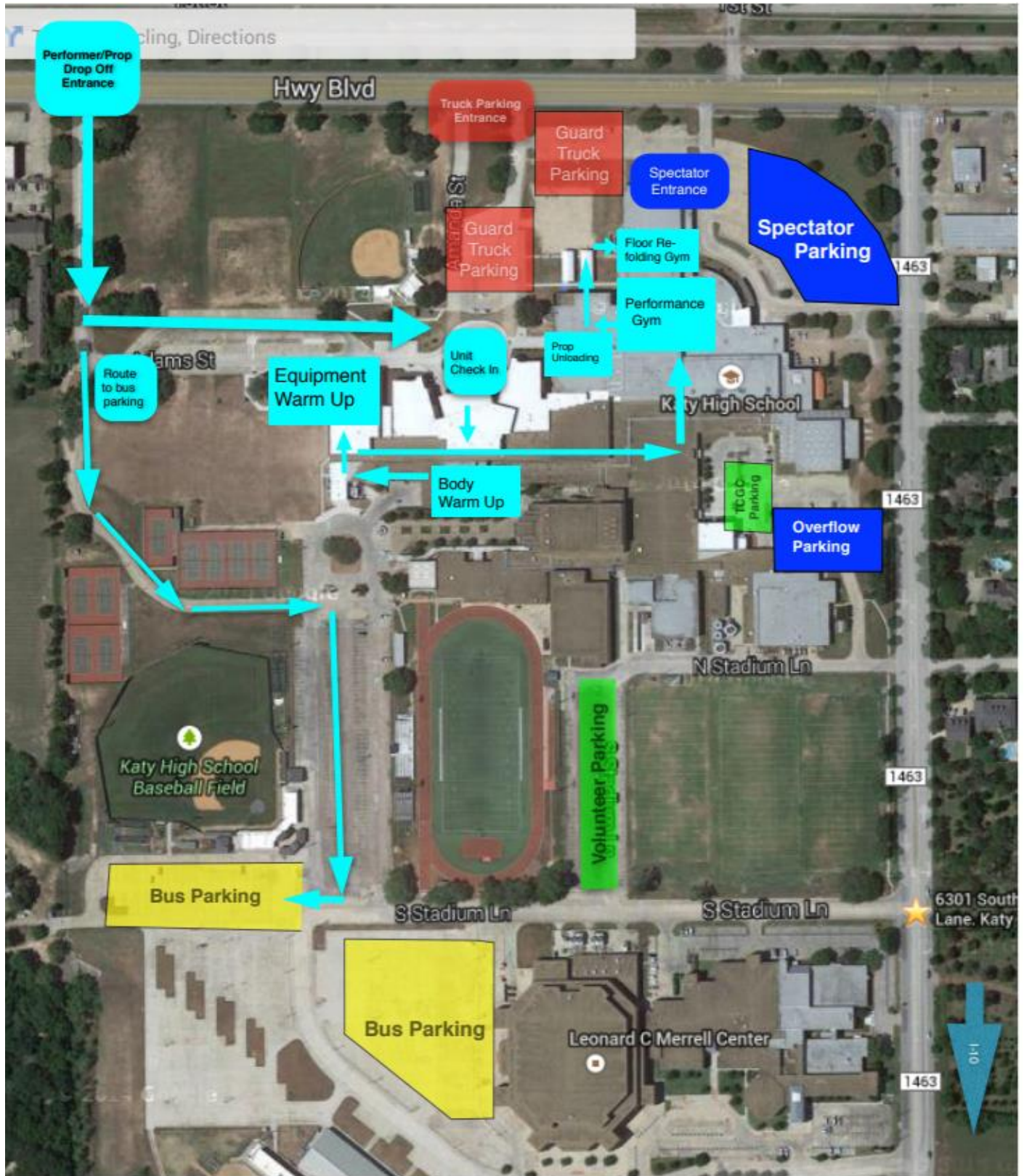
General Warm Up: 74ft by 132ft (Cafeteria- usually divided into 4 large sections for 4 units at a time)

Body Warm Up: Two classrooms with the divider wall removed. Carpet. Speaker provided.

Music may be used in body warm up at moderate levels to be determined per the contest administrator.

Equipment Warm Up: 60ft by 94ft (Gym)

Music may be used in equipment warm up at moderate levels to be determined per the contest administrator.

Competition Area

All TCGC contest sites must have a minimum of seventy by one hundred feet (70' x 100') to accommodate a "safety zone" of five (5) feet from any spectator seating. If no spectators are seated on the left and right sides, then the safety zone will be eliminated on the left and right sides of the competition area and can extend to a maximum of 110' x 78'.

The "competition area" at this event measures 100' x 66'. All performing groups must be prepared to perform within that area. Floors (tarps) may not extend into safety zones per rules found in the WGI Adjudication Manual and Rulebook.
