Front Side Bleacher Rows: 16

Seating Capacity: 800 Approximate

- There are no permanent obstructions above the competition floor.
- Units do not enter the competition area directly from the outdoors.
- There is electrical power available at the front and back sideline.
- Units do not exit the competition area directly to the outdoors.
- The hallways will be utilized for prop storage prior to the competition.
- There will be a black vinyl tarp measuring appx 60' x 90' covering the wooden gym surface.
- An indoor space is available for floor folding.

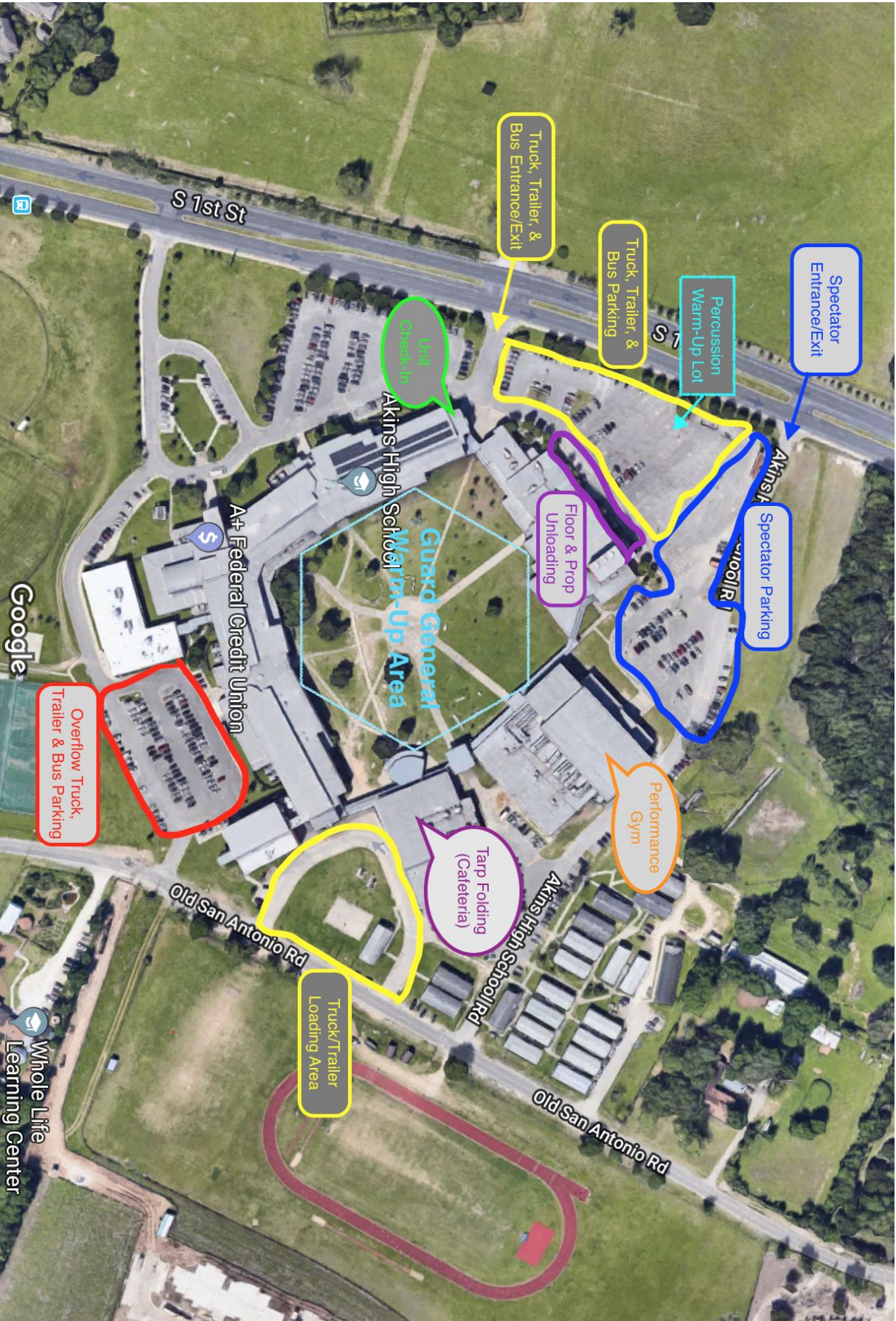
General Warm Up: Outside Courtyard

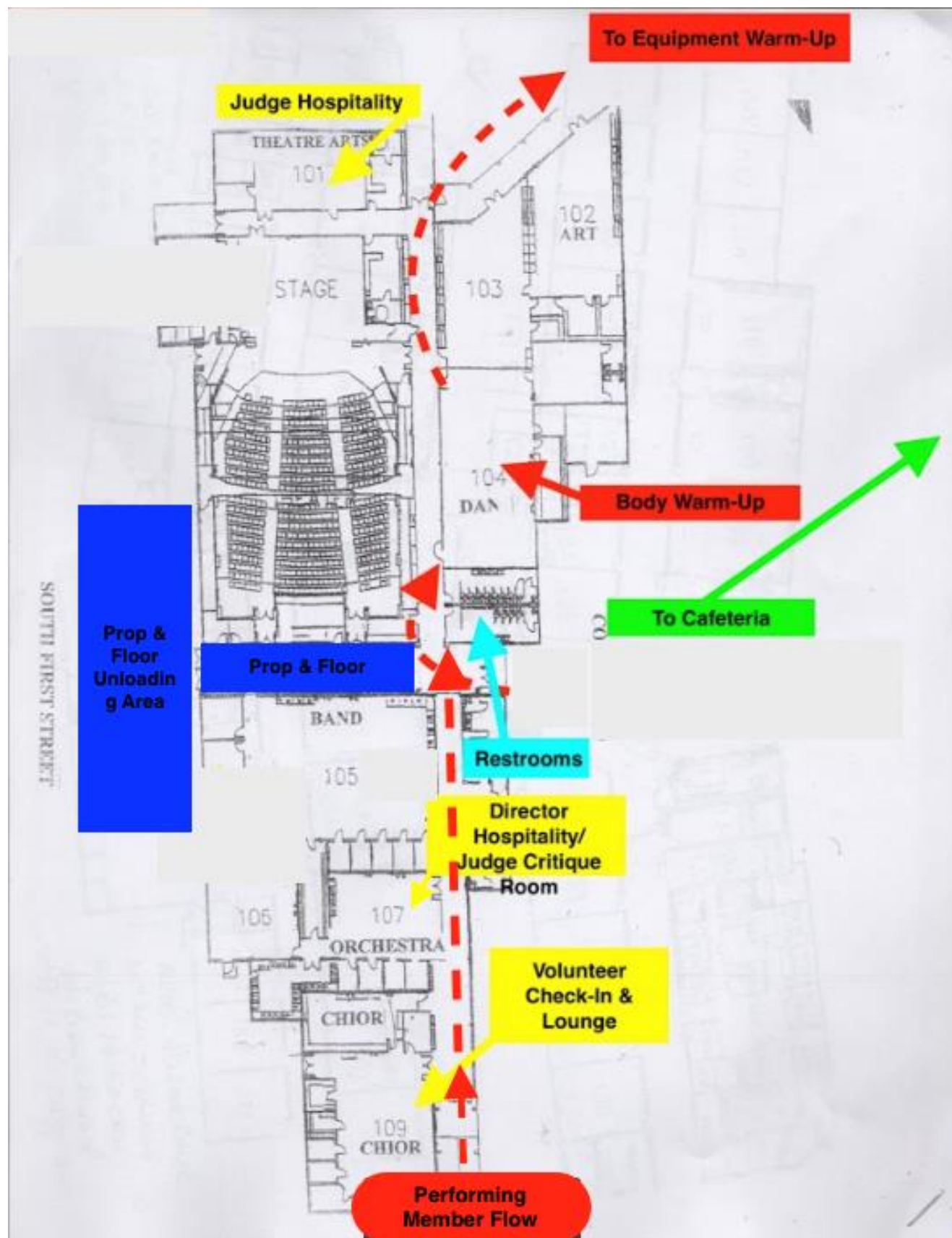
Body Warm Up: 60 Feet Long, 30 Feet Wide. Dance Room. Three walls are covered in mirrors.

Music may be used in body warm up at moderate levels to be determined per the contest administrator.

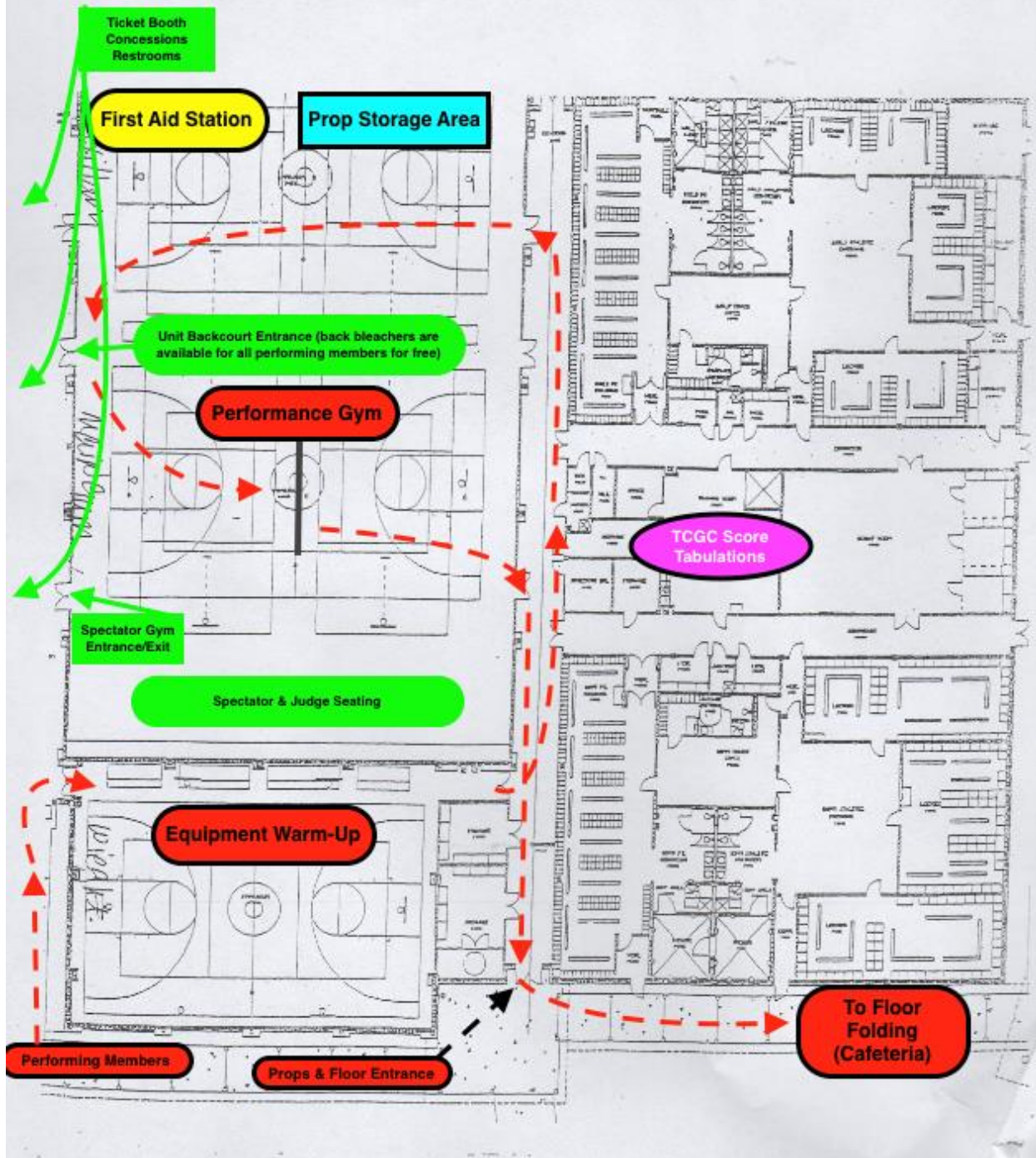
Equipment Warm Up: 80 Feet Long, 60 Feet Wide. Small gym next to the performance gym.

Music may be used in equipment warm up at moderate levels to be determined per the contest administrator.

Competition Area

All TCGC contest sites must have a minimum of seventy by one hundred feet (70' x 100') to accommodate a "safety zone" of five (5) feet from any spectator seating. If no spectators are seated on the left and right sides, then the safety zone will be eliminated on the left and right sides of the competition area and can extend to a maximum of 100' x 70'.

The "competition area" at this event measures 90' x 60'. All performing groups must be prepared to perform within that area. Floors (tarps) may not extend into safety zones per rules found in the WGI Adjudication Manual and Rulebook.
