### **General Contest Info**

### SPECTATOR ENTRANCE:

Spectators with a wristband will enter through the main entrance doors, which are located on the east side of the arena (please see maps).

### NO CLEAR BAG POLICY:

ASU will NOT be enforcing the clear bag policy, but be prepared to have your bags checked. No outside food or drink allowed.

### SPECTATOR/STAFF PARKING:

Packard and Stadium Structures will be available Friday and Saturday. Friday is a working business day on the university and parking structure fees will apply. \$3.00 an hour or \$15.00 per day. Saturday parking structures are free. 365community events will be taking place both nights so please allow enough time prior to your student's performance time.



### STAFF VIEWING LOCATIONS:

There will be one staff viewing area located at the top of section L. There is to be no sitting on the stairs or aisles.

The staff viewing area is reserved for staff of the currently performing ensemble's performance. After your ensemble has performed, please find an alternate seating location to enjoy other performances.

### SOUND SYSTEM & SOUND CHECK:

One hour prior to the start of the contest and during breaks at the discretion of the Contest Administrator. Each unit should have a staff member present at the sound booth in case any issues arise. See WGI Policy below for more details.

### **HOSPITALITY:**

A hospitality area will be available for directors and staff during the contest on the south concourse level of the arena in Room 116. This area is for staff, directors and Hall of Fame persons only. Please no parents or bus drivers.

### **UNIT CHECK IN:**

Check in will be located near the bus parking in lot 10. For those who attended ABODA State Championships, this is the same location they used for unit check-in. Check-in WILL BE AVIALABLE for EVERYONE beginning on FRIDAY. Those who are performing on Saturday but want to assist with groups performing Friday, may check-in Friday and get their wristbands. Performer wristbands are good for BOTH days.

### **PASSES:**

Units will be given 7 staff wristbands in addition to the performer wristbands for entrance passes. These will be distributed at Unit Check-in. Your unit badges WILL be recognized this year. PLEASE REMEMBER YOUR BUS/TRUCK DRIVERS!

- Directors can pick up packets Friday for both Friday and Saturday performers.
   Wristbands are good for both days and if removed it will be up to the unit to purchase a replacement, NO EXCEPTIONS
- To prevent a delay in show, WGAZ asks that all performers, staff and parent/volunteers to be wearing their wristbands at all times during WGAZ Championships.
- WGAZ is requesting anyone wearing a performer wristband to sit in their designated areas while inside Wells Fargo Arena.



### **UNIT WARM UP:**

All maps are in this packet. ALL UNITS should check in and be on site at least one hour prior to performance time.

### PERCUSSION/WINDS:

- o FRIDAY/SATURDAY MORNING: Percussion units can warm up around the truck parking area (please see maps), 1 hour BEFORE their scheduled transit time to the arena. Please face away from the stadium so that the sound does not bleed into the stadium. Floor tarps (both "practice" and "performance") are <u>NOT</u> to be pulled out during warm-up. All equipment must be removed from the warm-up area before you depart for your performance.
- Saturday Evening: Percussion units performing Saturday night will be allowed to park in Lot 59 between the solar panels and will warm-up in Lot 58 under the solar panels due to the Perry Concert on the Sun Deck.

### COLOR GUARD:

o All warm-up will take place around Wells Fargo Arena. There will be no inside warm-up this year (see attached). Warm-up in other areas or at other times is prohibited. Floor tarps (both "practice" and "performance") are not to be pulled out during warm-up.

### **CRITIQUE:**

Will only be offered for those teams headed to Winter Guard International Championships.

### **BUS/TRUCK PARKING:**

Unit parking is guaranteed for buses and carpool vehicles carrying (6) or more performers in lot 10. Trucks and Semi's will park in lot 59 west of the electrical towers closest to the buttes. Dropoffs cannot be accommodated. (Please see logistical for arrival and departure time off vehicles).

### **RESTROOMS:**

Restrooms are available in the Northeast tunnel of Sun Devil Stadium and in Wells Fargo Arena for those with a wristband/badge.



### WATER:

WGAZ highly encourages you to provide water for your performers. Water stations will be made available in warm-up, unit entrance and floor folding areas.

### ADDITIONAL INFORMATION:

Please be aware that the new 365community outreach is in full swing this weekend. Friday night there will be a movie played on the field in SDS. When moving through the stadium please do not play your instruments or stop to watch the movie. Please be aware of small cord covers that you will also need to move over for the speakers.

Saturday night the band Perry will be doing a sound heck as well as a concert, so please no playing near the stadium and no stopping along the route while moving through the stadium.

### **VIDEO & PHOTOGRAPHY:**

As safety is paramount to all performers, any type of flash photography is strictly prohibited. Family, friends and fans may take still photos of WGAZ events for personal use only. Small, non-professional, single frame "point & shoot" cameras are allowed into all venues. Any camera that has a detachable lens or lens' that extends to four (4) or more inches is considered a "Professional Camera" and thus prohibited.

There is no video recording permitted at any WGAZ event. Any liability associated with unauthorized recordings will rest with the individual or organization making the recording. WGAZ does not condone, nor accept any liability for, any unauthorized recording during the event.





### From the 2019 WGI Policy Manual

### 4.120 Sound Policy (Color Guard)

- All color guards should do a sound check at the designated times provided in the contest information packet to ensure the playability of any device or CD. Color guards should check the soundtrack at multiple places in the music to verify playability of any device
- Color guards should still do a sound check if they are using the WGI Music Upload in CompetitionSuite to ensure everything is correct.
- Color guard is responsible for providing the method that the music will be played, e.g. CD, MP3, computer, etc. Each color guard should have two methods to play their soundtrack in the event one does not work.
- Color guard must provide their music in a timely manner to the designated sound operator. Any delay in providing music is the responsibility of the color guard.
- Color guards using the Music Upload process through CompetitionSuite should have a backup using another device type such as an MP3 player, iPhone, or CD.
- Color guard must have a designated person at the sound table to operate any device provided to play music such as MP3 players or computers. Guard's representative is responsible to set up and play device. If a CD is provided, the color guard representative must instruct the sound operator as to what track or other relevant information is needed to start the music when directed by the contest Timing and Penalty judge or after the color guard's introduction.
- If the color guard has an issue with the music such as music is too soft, it begins in the wrong place or skips, the color guard's representative must make the decision to stop the music and tell the operator to stop the music. If the color guard representative chooses not to stop and the color guard completes their performance, the color guard will not be offered an opportunity to perform again.
- Interval timing will continue as the color guard resets and begins again. The Contest Administrator has the sole discretion in waiving any timing penalty due to the restart. If the stoppage is due to faulty sound equipment, operator error or an unexplained reason, overtime penalty may be waived.
- Issues related to the equipment provided by the color guard, quality of the CD or the color guard's representative error (using wrong playlist on MP3, etc.) will result in the actual interval timing being used and penalties, if any, being assessed.
- Volume direction must come from the color guard representative at the sound table. Direction
  will not be taken from the audience viewing area or across the floor. Final volume discretion is
  given to the sound operator based on their equipment and the Chief Judge who ultimately
  determines an appropriate volume level.
- The color guard representative may provide direction to the sound operator during the performance regarding equalization.
- It is the responsibility of the color guard to provide their music for each performance and to ensure that their soundtrack is working appropriately. CDs may not be left at sound table between performances.
- Under no circumstances will verbal abuse of the sound operator be tolerated. Penalties will be assessed per current WGI rules
